Agreement/Waiver

In consideration for becoming a member of the Victoria Supermoto Association, and/or being permitted to compete, officiate, observe, work or participate in any way the EVENT(S), or entering for any purpose the RESTRICTED AREA (defined as the racetrack, pit areas or any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited) : I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREA, sponsors, advertisers, owners and lessees of the premises to conduct the EVENT(S), and each of them, their directors, officers, agents and employees, herein referred to as "releasees," FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO ME OR MY PROPERTY OR RESULTING IN MY DEATH ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE TO ME arising out if or related to the EVENT(S) whether caused by the NEGLIGENCE OF RELEASEES or otherwise, and acknowledge that taking part in MOTORSPORT ACTIVITIES IS A DANGEROUS. I HEREBY AGREE that this Release and Waiver of Liability and Assumption of Risk Agreement (hereafter WAIVER) extends to all acts of negligence by the Releasees, including negligent rescue operations. I AGREE to obey the Victoria Supermoto Competition/Practice Rules (including maintenance, setup, and fees) and to respect the authority of Western Speedway officials and personnel at all events. I FURTHER AGREE that Victoria Supermoto Club may freely use my name, likeness and pictures of myself and racing equipment taken at any event, for purpose in the media and/or any type of promotion for Victoria Supermoto Club or Western Speedway. I STIPULATE that all the statistical and personal information I have submitted is true and correct under penalty of perjury. I have read and understand this WAIVER, understand that I have given up substantial rights by signing it, and have done so freely and voluntarily without any assurance or guarantee. Most importantly, I promise to have fun, maintain a positive attitude, and do what I can to further the growth of the club.
